ALLEN TOWNSHIP SUPERVISORS MEETING MINUTES

Thursday, November 9, 2017

A <u>General Meeting</u> of the Allen Township Supervisors was held on Thursday November 9th, 2017 at 7:00 P.M. at the Allen Township Municipal Building, 4714 Indian Trail Road, Northampton, Pennsylvania 18067. The Pledge of Allegiance to the Flag was led by Chairman Larry Oberly.

A. Presentation: Allen Township Lehigh River Properties - Lauren Golden, Trail and Stewardship Manager, Delaware & Lehigh National Heritage Corridor, Inc.: Ms. Golden gave an overview of the D&L National Heritage Corridor.
